If circumstances are required PLEASE GET TESTED AND ISOLATE

ENTERING THE STUDIO + VACCINATIONS

- **Only Fully Vaccinated patrons and students aged 12 + 2 months up may enter the Premises.**
- **You must be prepared to show proof of vaccination. Regular patrons and enrolled students only need to do this once.**
- No records will be held or kept by A.N.D.S. Only Employees vaccination status must be recorded and sighted.
- Please sanitise when entering and either **QR in or sign in the covid guest book** via our **Victorian App** upon entry.

DENSITY LIMITS

- 25 people are allowed across the venue before density limits apply (excluding staff)
- For more than 25 in the venue One person per two square metres per usable indoor space (exc staff)
- Studio 1 = 30 people, Studio 2 = 9 people, Reception 8 people (exc staff + if over 25 in venue)

COVID CASE RULES AND CONTACTS

- If you have been a close contact of a positive case we ask you follow the same advice as given by DHHS Victoria.
- If you are suspected of being a confirmed case, close contact, having symptoms, getting tested or waiting for results of a test, we prefer you do not come to dance until you have received a negative result. Please contact the principal if you are unsure of your situation.
- If a student/staff/patron has been diagnosed as a confirmed case of Covid 19, but may not have attended the premises. You must call, text or email the principal asap to help ensure a spread has not taken place on our premises.
- If a student/staff/patron has been diagnosed with covid 19 and has attended the premises, you must contact the principal immediately. An immediate shutdown and necessary protocols such as cleaning or contacting other students/staff/patrons and there of will need to take place, even outside the QR tracing.
- In the case of a high amount of possible cases or suspected close contacts within the school are at risk, testings or isolating. ANDS reserves the right to shut down classes for up to 24-48 hrs if deemed necessary to ensure continues safety of all patrons.

CLEANING + MAINTENANCE

Our studio premises ensures we maintain cleaning before, during and after use of all classes.

- Cleaning bathrooms before and end of night
- Wiping and spraying down all touched surfaces such as railings, door handles, benches + shelves
- Sanitiser available at entries, reception and inside studios or rooms used for dance
- If required mats and props used are to be cleaned and sprayed after use
- All staff have been advised and trained in all cleaning protocols

COVID + SAFETY PLANS for A.N.D.S attending outside events and/or performing venues

- We ask all students carry their own sanitiser with them for their own use also. Ensure you continue to keep up hygiene by washing/sanitising hands, especially when using bathrooms
- If aged over 12 + 2 months you must be prepared to show your vaccination status to enter the venue if required
- All staff/patrons + students or parents/guardians of students must QR in or sign in to venue if required.
- If required to wear a mask depending on the current rules and settings, please have one with you.
- Same rules apply regarding any type of viral sickness, or suspected case/close contact of Covid. Please stay home.
- Do not share food or drink bottles outside your family member/or partner.
- Do not be barefoot anywhere but on a surface of performance like a stage
- Adhere to all social distancing rules and any other imposing rules placed upon the venues requests.
- ANDS Staff/Venue operators reserve the right if deemed necessary to call an ambulance for any emergency style situation deemed dangerous and/or life threatening. And that all ambulance fees are covered by the patient/patients family.
- In the instance a case or severe viral infection arises even if not covid related within a performer/performers whilst onsite you must let the principal & venue operator know asap. If circumstances are required an immediate shutdown may take place where all parents/guardians will be contacted to pick up their child as soon as possible.
